

How to access required courses on www.convergeconnect.org

- 1. Type <u>www.convergeconnect.org</u> into your search bar.
- 2. Click the Log In button in the top right of your screen.
 - a. This step is the same for folks who need to create an account and for those who already have one!



If you do not have an account, click "Create new account"
 a. If you already have an account, log in and skip to step 5







- 4. Fill out the required fields and click "Create my new account"
 - a. When you get to the question circled in yellow "Are you a part of Converge's Title X Network" select yes. A drop down menu will appear. Please select the name of the clinic where you work. If you do not see your clinic name, select "Other" and email Dani Lahn <u>dlahn@convergeaccess.org</u> to get your clinic added.
